

Discipline Specific Selection Criterion

2025 BMX RACING WORLD CHAMPIONSHIPS

Elite Men and Women | U23 Men and Women | Junior Men and Women

1. General

- I.1 Athletes will be required to earn 2025 UCI BMX Racing World Championships Team selection in accordance with clause 1 of the *AusCycling Selection Policy for UCI World Championships*, and this discipline specific document of the AusCycling (AC) selection criteria.
- I.2 Objectives: See clause 1 of the AusCycling Selection Policy for UCI World Championships.
- I.3 Performance Time Period:
 - Elite men and women, U23 men and women:** 17 May 2024 – 15 June 2025
 - Junior men and women:** 17 May 2024 – 15 June 2025
- I.4 Team size: Refer to clause 3.3 of the *AusCycling Selection Policy for UCI World Championships*.

2. Selection Criteria

- 2.1 Consideration for selection to the 2025 BMX Racing World Championships Team may be based upon athletes achieving;
 - i. Performances in Section 3 of this document, and/or
 - ii. In accordance with clause 2.2 of the *AusCycling Selection Policy for UCI World Championships*, where selectors may use absolute discretion.
- 2.2 Where more athletes meet the criteria than there are places available, selectors may use absolute discretion to rank athletes according to some or all the factors in clause 2.2 of the *AusCycling Selection Policy for UCI World Championships*.



3. Selection Events and Performance Standards

- 3.1 If men elite or women elite attain a minimum of two (2) performances as per the listed events and standards at 3.1.1 during the performance time-period, they will be favourably considered for selection by the National Selection Panel. If athletes do not attain such performances, they may be considered for selection in accordance with clause 2.2 of the *AusCycling Selection Policy for UCI World Championships*, where selectors may use absolute discretion.

- Top 8 - 2024 Olympic games
- Top 8 - 2024 UCI World Championships (Elite)
- Podium - 2024 AusCycling BMX Racing National Championships (Elite)
- Podium - 2024 AusCycling BMX Racing National Championships (Superclass)
- Top 8 – 2025 UCI World Cup Rounds 1 & 2, Sarrians, FRA (Elite)
- Podium - 2025 Oceania Continental Championships (Elite)
- Podium - 2025 AusCycling BMX Racing National Rounds Shepparton and Lake Macquarie (Superclass)
- Top 8 - 2025 USA BMX Pro Series - Carolina Nationals, Golden State Nationals, Music City Nationals
- Top 8 – 2025 European Cup Rounds – Verona, Heusden-Zolder, Lempdes

**AusCycling National Rounds will be run as a 16+ Superclass. Only the Podium place finishers at the event will be considered for Elite Team Selection.*

- 3.2 The National Selection Panel may consider the performance outcomes and standards indicated below for U23 men and women. If athletes attain a minimum of two (2) performances in the events listed below at 3.2.1 during the performance time-period, they will automatically be eligible for consideration. If athletes do not attain such performances, they may be considered for selection in accordance with clause 2.2 of the *AusCycling Selection Policy for UCI World Championships*, where selectors may use absolute discretion.

- Top 8 - 2024 World Championships (U23)
- Podium - 2024 AusCycling BMX Racing National Championships (U23)
- Podium - 2024 AusCycling BMX Racing National Championships (Superclass)
- Top 8 – 2025 UCI World Cup Rounds 1 & 2, Sarrians, FRA (U23)
- Podium - 2025 Oceania Continental Championships (U23)
- Podium - 2025 AusCycling BMX Racing National Rounds Shepparton and Lake Macquarie (Superclass)
- Top 8 – 2025 USA BMX Pro Series - Carolina Nationals, Golden State Nationals, Music City Nationals
- Top 8 – 2025 European Cup Rounds – Verona, Heusden-Zolder, Lempdes (U23)

**Any rider wishing to compete in the Elite category from 1 January 2025, will not be eligible for U23 selection.*

***AusCycling National Rounds will be run as a 16+ Superclass. Only the Podium finishers at the event will be considered for U23 Team Selection.*



- 3.3 The National Selection Panel may consider the performance outcomes and standards indicated below for junior men and junior women. If athletes attain a minimum of two (2) performance in the events listed below at 3.3.1 during the performance time-period, they will automatically be eligible for consideration. If athletes do not attain such performances, they may be considered for selection in accordance with clause 2.2 of the AusCycling Selection Appeals Policy for UCI World Championships, where selectors may use absolute discretion.

- Top 8 - 2024 World Championships (Junior)
- Podium - 2024 AusCycling BMX Racing National Championships
who is eligible to compete in Junior in 2025
- Top 8 – 2025 UCI BMX Race World Cup Rounds 1 & 2, Sarrians, FRA, (U23)
- Top 8 - 2024 AusCycling National Championships (Superclass)
- Podium at the 2025 Oceania Continental Championships (Junior)
- Top 8 - 2025 USA BMX Pro Series - Carolina Nationals, Golden State Nationals, Music City Nationals
- Top 8 – 2025 European Cup Rounds – Verona, Heusden-Zolder, Lempdes (Junior)
- Top 8 - 2025 AusCycling National Rounds Shepparton and Lake Macquarie (Superclass)

**AusCycling National Rounds will be run as a 16+ Superclass. Only the Top 8 finishers at the event will be considered for Junior Team Selection*



4. Schedule for World Championships Team Selection

- 4.I The timeframes for the selection process of the World Championships Team to contest the 2025 UCI BMX Racing World Championships* are:

Selection Timelines

- Tuesday, 17 June 2025(5PM AEST) – Deadline for submission of recorded performances for selection purposes (AusCycling internal deadline)
- Friday, 20 June 2025 (5PM AEST) – Final team selections forwarded to AusCycling CEO for endorsement.
- Wednesday, 25 June 2025 (5PM AEST) – Athletes receive confidential notification of selection / non-selection to the BMX SX World Championships Team
- Friday, 27 June 2025 (5PM AEST) – Closing date for appeals to be lodged against non-selection (refer to the AusCycling Selection Appeals Policy for UCI World Championships, clause 7)
- Week of Monday, 30 June 2025 - Week scheduled for appeal hearings, if required
- Week of Monday 7 July 2025 (5PM AEST) - Final BMX Racing World Championship Team announced by AusCycling

**selected Junior and U23 athletes will be required to pay a levy to attend the 2024 BMX Racing World Championships. Estimated levy costs will be provided closer to selection.*
