Under clause 13.3(d) of the AC Constitution, AC hereby calls for nominations for retiring Elected Director positions. Eligibility of candidates is governed by clause 13.2 of AC's Constitution. Information on the process for director nominations will be communicated separately.

Formal notice of the Annual General Meeting, including the agenda, will subsequently be delivered by no later than 7 May 2026. The Annual General Meeting is intended to be held by videoconference, with registration details to be provided by no later than 5:00pm AEST on 7 May 2026.

Under clause 12.1 of the AC Constitution, AC has set the cutoff date of 30 April 2026 to calculate club membership numbers to assign the correct number of votes to Club Members (being the Voting Members for this AGM in accordance with clause 5.1(a) of the Constitution).
