## **DISCIPLINE SPECIFIC SELECTION CRITERION**

## Elite Track Men and Women 2024 UCI Track Cycling World Championships

16 - 20 October 2024 I Ballerup, Denmark

#### 1. GENERAL

- **1.1** Athletes will be required to earn 2024 UCI Track Cycling World Championship team selection in accordance with clause 1 of the *AusCycling Selection Policy for UCI World Championships*, and this discipline specific document of the AusCycling (AC) selection criteria.
- **1.2** Objectives: See clause 1 of the AusCycling Selection Policy
- 1.3 Performance Time Period: 1 August 2023 12 August 2024
- **1.4 Team size:** Refer to clause 3.3 of the *AusCycling Selection Policy for UCI World Championships*.
- and/or State and Territory Government laws regarding COVID-19. When travelling as part of the National Team, all athletes are to comply with the relevant State/Territory/Country COVID-19 restrictions, COVID-19 testing, or vaccination requirements, and any additional measures implemented by AusCycling where necessary. AusCycling strongly recommends individuals to be fully up to date with their COVID-19 vaccinations prior to travel. If vaccination is required due to State/Territory/Country COVID-19 entry requirements, but vaccination is not appropriate due to underlying health conditions or other, athletes will be required to obtain both a medical report from a registered medical doctor validating the condition(s) and their basis for contraindication to vaccination.

#### **Track Specific Eligibility**

- **1.6 UCI qualification articles 9.2.027bis** (below) will be applied when making selections for events for the 2024 UCI Track Cycling World Championships.
  - 1.6.1 A nation will only be allowed to enter a rider in a specific event of the Elite World Championships if the following conditions are fulfilled:

- where applicable, the nation must have participated in this specific event in at least one leg of the Nation's Cup of this season. This only applies when the specific events are scheduled at each leg of the Nations' Cup.
- where applicable, the nation must have participated in this specific event in the most recent Elite Continental Championships.
- the nation must have participated in the most recent Junior Track World championships (note event specific).
- a rider must have earned, for the specific individual event and for Madison, at least 250 points in the respective UCI Track Ranking used for the establishment of qualification quota as per 9.2.023. This does not apply to riders entering Individual Pursuit and Kilometre/500m Time Trial.

#### 2. SELECTION CRITERIA

- **2.1** Consideration for selection to the 2024 Track Cycling World Championships Team may be based upon achieving:
  - i) Performances in Section 3 of this document, and/ or
  - ii) In accordance with clause 2.2 of the *AusCycling Selection Policy for UCI World Championships*, where selectors may use absolute discretion.
- **2.2** Where more athletes meet the criteria than there are places available, selectors may use absolute discretion to rank athletes according to some or all of the factors in clause 2.2 of the AusCycling Selection Policy for UCI World Championships.

#### 3. PERFORMANCE STANDARDS

- 3.1 The selection panel may consider the performances standards indicated below for Elite Men and Elite Women Olympic events, Sprint, Keirin, Team Sprint and Team Pursuit, Omnium and Madison.
- 3.2 In Team events (Team Pursuit, Team Sprint, and Madison) the selection panel may consider an Athlete's contribution to the overall event performance, as determined by the National Head Coach for Acceleration and Action and / or the National Head Coach for Endurance.
  - 3.2.1 For Team Pursuit selections, the selection panel may also consider athlete performances in an event or trial approved by the Head Coach Endurance that meet the performance standards indicated below in Individual Pursuit.

For all selection, all considered performances must be recorded on video as per the standards in the AusCycling Trial Recording and Environmental Standardisation Protocol.

3.3 The selection panel, using absolute discretion, may consider selection to the non-Olympic events: Individual Pursuit, Kilometre Time Trial, 500m Time Trial, Points Race, Elimination Race, and Scratch Race, subject to Australia, and the relevant athletes, meeting Nation and UCI athlete nomination eligibility.

#### 4. SCHEDULE FOR 2024 TRACK CYCLING WORLD CHAMPIONSHIP TEAM SELECTION

- **4.1** The timeframes for the selection process of the 2024 UCI Track Cycling World Championships Team to contest the 2024 Track Cycling World Championships are:
  - Tuesday, 20 August 2024 (5PM AEST) Deadline for submission of recorded performances for selection purposes (internal AusCycling Deadline for National Coaches only).
  - Friday, 23 August 2024 (5PM AEST) Final team selections forwarded to AusCycling CEO for review.
  - Tuesday, 27 August 2024 (5PM AEST) Athletes receive confidential notification of selection / non-selection to the Track World Championships Team.
  - Thursday, 29 August 2024 (5PM AEST) closing date for appeals to be lodged against non-selection (refer to the AusCycling Selection Policy for UCI World Championships, clause 7).
  - Monday, 2 September 2024 Scheduled week for appeal hearings, if required.
  - Monday, 9 September 2024 Final World Championship team announced.
