World Championship Selections—First Instance Appeal — NST Workflow

Important components of a Selection Appeal

The Appeal Process starts at Clause 5

Remember to continually refer to and **closely follow the process and timeframes** stipulated at clause **5. Appeals Process**, of the AC Selection Appeals Policy for UCI World Championships. The process requires athletes to submit information to the CEO of AC. If the dispute cannot be resolved within the timeframe on page 2 of this document, then the athlete may proceed to a First Instance Appeal at the National Sports Tribunal – **refer clause 5.2.**

Understand the Grounds for Appeal

An athlete may bring a Selection Appeal to the NST **only** on one or more of the grounds stipulated in the AC Selection Appeals Policy for UCI World Championships **clause 5.2(b).** Athletes are encouraged to read clause 5.2 carefully prior to commencing the Appeal process.

How much does a Selection Appeal to the NST cost?

Generally, an application fee is required by the NST. Refer to Slide 3 for a link to the NST website which will provide you with further information on the fee and how to apply.

The AC Selection Appeals Policy for UCI World Championships refers to an Interested Party. Who is an Interested Party?

In a non-Selection dispute, an additional party may be permitted to participate in a hearing such as an interested athlete (being an athlete who could possibly be displaced from the team if the appeal is successful).
